### Tournament Rules

1. Players start with 10,000 in tournament chips.
2. Blind levels last 20 minutes. Registration will be open for the first 3 levels. Players may re-enter during registration.
3. TDA Rules will be in effect for this event.
4. Each player will pay a \$130 fee. \$97 is the entry fee, \$3 will go towards the promotion fee, \$10 staff fee, and \$20 is the registration fee.
5. 100% of all tournament promotion fees will be paid to the players in the Tournament Leader Board Promotion. The payments will be in the form of tournament entries or tournament entry chips.
6. \*\*This event will not occur the 1<sup>st</sup> Friday each month, if there is a scheduled \$50,000 Guaranteed Tournament.\*\* This tournament will have a guaranteed prize pool of \$5,000. In the event the prize pool does not reach \$5,000, the difference will be added from the Beau Rivage Poker Room Promotion Fund.
